

So I thought it would be interesting to take a look at the direction the wind has been blowing during the current lake season. The illustration shows the number of days during May, June and July that the wind blew in a given direction for at least a 4 hour period. (Some days it might have blown from three different directions.) The length of the arrow is proportional to the number of days the wind blew that direction.

I must confess that I may have lost my bet with a former board member who believes the wind blows toward his north shore home a lot more than my southwest shore home --- but I still think it blew my way every day during the carp floating season.



Aquatic Plant Management/Invasive Species Subcommittee

These are notes from a meeting on August 26, 2009. Tom McGinnis and Peter Foy from FOLKS met with Kevin Connors, Director Dane County Land and Water Resources Department, Darren Marsh, Director Dane County Parks. This is the second part of a two-part article. The first part was published in the January 2010 newsletter.

What are their biggest problems?

- Budget. They could only hire 6 operators this year and then had to discontinue the cutting a month earlier than planned because they ran out of money.
- Timing. A major problem is that three of the four lakes need the most attention at the same exact time because of when the weeds get bad. Lake Mendota is different because it is larger and colder and weeds develop later than the others.

Harvesting history

The good news is that the County has recognized that increased weed cutting is necessary on Lake Kegonsa. Despite this, due to budgetary issues the total number of hours spent on all Dane county waters was reduced by 1,076 hours between 2008 and 2009, the hours spent on Lake Kegonsa increased from 217 to 324.

We did identify some areas that FOLKS could possibly help. Most of these ideas cost money and the FOLKS Board will evaluate the payback for the money spent and decide what to consider for the 2010 Budget.

- We asked about the possibility of us paying the employees to continue cutting in Lake Kegonsa using their equipment. They told us that it would cost \$500 a day for two cutters, fuel and a truck driver. We would have to work closely with them to insure they would work just on Lake Kegonsa. We wouldn't pay if they weren't on our lake
- Hire their Aquatic Vegetation Scout to do detailed analysis of Lake Kegonsa to determine changes and need for additional cutting. This would probably be a good investment. The more time he spends the more accurate information we will get about potential problems on our lake.
- The Aquatic Plant management Plan is due for update in 2012. The last plan cost \$15,000. This is required for a new permit to be issued. Any areas identified that require additional cutting could be included in the plan/permit. If there are budget issues they may have to apply for an extension of the current plan. FOLKS could possibly help fund part of a new plan to insure that one gets done.
- Identify additional weed drop off points
