By the way, in our contest I estimated that the ice would be off the lake on March 20th. As I write this it looks like it is going to be later than that. I still have hopes that we will be on the water pretty soon.

Protecting The Lake Kegonsa Waterfront

In seeking to be a good steward of our natural resources, the UW-Extension Center for Land Use Education has been a good resource for obtaining information. I found a publication named <u>Protecting Your Waterfront Investment</u>.

The publication highlighted simple shore land stewardship practices that will be a good reminder for all of us as we head into the spring of 2013.

- Curb Pollutants at their source fertilizers, household toxins, eroding soils, and malfunctioning septic systems. Choose a zero phosphorus fertilizer; phosphorus accelerates algae growth. Based on a study of 236 lawns sampled in Dane County, the average available soil phosphorus concentration was approximately four times higher than the amount needed to maintain a healthy lawn.
- Cut the amount of runoff that picks up pollutants and carries them to the waterway by minimizing the hard surfaces that create runoff. Beyond minimizing erosion during construction, soil exposure in established homes affords homeowners opportunities to reestablish native species suited to shore land. Shore land species can be found on the Wisconsin State Herbarium website: http://www.botany.wisc.edu/wisflora/
- Capture and cleanse pollutant carrying runoff before it reaches the waterway with shoreland buffers, rain barrels or rain gardens.

Directing downspouts onto the lawn or landscaping and not on to hard surfaces reduces run off into the lake. Installing a rain barrel that collects water from rooftops will provide water for the yard during dry periods.

Purchase a Rain Barrel at the 2011 City of Madison Compost Bin Sale. This year they will offer a rain barrel for \$55 at the City's popular compost bin sale. This one-day event is May 7 at the Alliant Energy Center. http://www.cityofmadison.com/streets/compost/CompostBinSale.cfm

Rain Gardens are just what they sound like; areas that soak up rain water during wet times and provide a beautiful garden all the time. The gardens fill with a few inches of water and allow the water to slowly filter into the ground helping to slow the runoff and allowing it to soak into the ground rather than flowing into the lake. Additional benefits include providing a wildlife habitat for birds, butterflies and dragonflies.

Clean Lakes Alliance



Last newsletter we ran an article regarding the Clean Lakes Alliance (CLA). Its mission is to continue to build a community of people, businesses, organizations and government agencies dedicated to continuously improving and protecting water quality in the Yahara watershed.

FOLKS was recently featured in a member profile in their latest Lake-O-Gram. The following is an excerpt of the profile:

Friends of Lake Kegonsa Society (FOLKS) is a local non-profit devoted to the preservation and enhancement of Lake Kegonsa, the southernmost of the four Yahara Lakes. FOLKS was established in 1987 as a non-profit organization and has been partnering with CLA since 2012. Bryon Thompson is currently representing FOLKS on the CLA Community Board. Right now there are 350 active members of FOLKS that have contributed in many different ways to help Lake Kegonsa.

FOLKS has financed projects working on critical run-off reduction by Highway B and a retention pond near Barber Drive, both of which border Lake Kegonsa. In 2009, FOLKS did a lake level study to find out whether lake lowering has a positive attribution to increasing the flow rate between Lake Waubesa and Kegonsa. The bottom line, as noted by President Bob Arndt, is that "FOLKS is about more than just lake protection and conservation. It also advocates for its members - the property owners on the lakeshore - and works on other types of issues as well, such as boater safety."
